3. Processing of Private Personal Data

A number of personal data that carry the risk of being a "special quality" have been determined.

It is processed in the following cases, provided that adequate measures to be determined are taken:

If the personal data owner has express consent, or

If the personal data owner does not have express consent;

- Private personal data of the personal data owner regarding his health and sexual life can only be made public.
